## POSITION OBJECTIVE:

This position performs all duties necessary to promote the efficient operation of the Medical Device Reprocessing Department to meet the needs of the Surgical Program, and all end-users of resuable medical devices in providing quality patient care. MDRD duties include, but are not limited to: cleaning, decontamination, visual inspection and functionality testing, assembly, sterilization, and pick-up/deliery of all medical/surgical instrumentation/equipment; case picking, and adherence to all infection control procedures. Compliance with Quality Indicators and Standards for Sterilization and Reprocessing is an expectation. Shift rotations are subject to change as the OR has approximately 6 weeks of slow down per year, which varies year to year.

- o Grade 12 education or equivalent
- o Must hold a valid certification, or currently enrolled in M.D.R.A.O. (formerly C.S.A.O.) or recognized reprocessing program;
- o Demonstrated knowledge of surgical instrumentation, sterilization and infection control procedures (through education or experience)
- o Knowledge of, and experience in using proper body mechanics to meet the physical demands of this position for constant walking, prolonged standing, frequent bending, lifting, pushing/pulling carts as well as intense visual concentration for instrument processing
- o Demonstrated ability to handle a large and diversified workload with often rapidly changing priorities and challenging deadlines
- o Evidence of effective customer service, organizational, interpersonal, and communication skills
- o Ability to work effectively within a multi-disciplinary team where patient and staff safety, and service excellence is a top priority
